2019 ***International Conference on Romanticism***
Principal Organiser

A 4-day conference drawing approximately 200 international scholars as participants. Keynote speakers: Marlene Daut (UVA) and Anne-Lise François (UC Berkeley). The conference in Manchester marked the 200th anniversary of Peterloo; it is the first time that ICR took place in the UK.

I initiated the bid in January 2016 and oversaw from that time every aspect of conference organisation—from building the website to submitting funding applications, booking venues, vetting abstracts, selecting and introducing keynote speakers, and having a short film made of the event. In October 2018, I gave a planning report at the ICR Board Meeting in the U.S, and I hosted the ICR Board Meeting in Manchester during the summer 2019 conference. For the conference, I secured a \$2,600 grant from the academic journal *SEL: Studies in English Literature 1500-1900* (based at Rice University, published by Johns Hopkins University Press); £1,000 from the Byron Society; £300 from the journal *Essays in Romanticism*; £200 from the journal *Romanticism on the Net*; £1,000 from the John Rylands Research Institute; £300 from CIDRAL; £5,000 from SALC/Creative Manchester; and £500 from SALC Social Responsibility Fund.
